

Wyoming Unemployment Insurance Claims Information, June 2017: Claims Continue to Decline

Initial Claims

Prom June 2016 to June 2017, initial Unemployment Insurance (UI) claims decreased by 38.3% (-924 claims). At the industry level, the greatest decreases were seen in natural resources & mining (-249 claims, or -77.1%) and construction (-210, or -42.6%). All industries experienced a decrease in initial claims, with the exception of local government (an increase of five claims) and information (no change).

At the county level (county of residence), the greatest decreases were seen in Natrona (-184 claims, or -42.8%) and Campbell (-181, or -62.8%) counties. The number of initial claims from out-of-state claimants decreased by 150 claims, or 34.4%.

Continued Claims

Over the year, the number of unique claimants with continued claims decreased by 45.6% (-3,246 claimants). The number

of workers who exhausted their benefits decreased by 46.2% (-253 claimants). The total number of weeks claimed decreased by 54.9% (-15,845 weeks).

All counties and all industries experienced a decrease in total weeks claimed. The greatest decrease in continued weeks claimed were seen in natural resources & mining (-6,320, or -89.8%) and trade, transportation, warehousing, & utilities (-2,676, or -56.4%).

Natrona and Campbell counties experienced the largest decreases in continued weeks claimed at -3,464 (-63.4%) and -3,261 (-74.8%), respectively. The number of total weeks claimed by out-of-state claimants decreased by -2,816 (-55.4%).

These factors may indicate that workers with continued unemployment claims are having less difficulty finding employment in Wyoming or other states.





Figure: Total Number of Unemployment Insurance Continued Weeks Claimed in Wyoming, January 2008 to June 2017



Initial Unemployment Insurance Claims by Major Industry, June 2017




Initial Unemployment Insurance Claims by County of Residence, June 2017




