### Wyoming Unemployment Insurance Claims Report, October 2023 Continued Claims Up from 2022 Levels




Figure 1: Total Number of Initial Unemployment Insurance Claims for Wyoming by Year and Month, January 2013 to October 2023




Figure 2: Total Number of Unemployment Insurance Continued Weeks Claimed for Wyoming by Year and Month, January 2013 to October 2023

Initial and continued Unemployment Insurance (UI) claims followed their normal seasonal patterns and continued to increase from September to October (see Figure 1 and Figure 2, page 3). Initial claims (see Definitions, page 9) nearly doubled as seasonal employment ended in industries such as leisure & hospitality and construction.

### **Initial Claims**

There were 1,715 initial claims in October 2023, slightly lower than 1,763 in October 2022 (-48, or -2.7%). Initial claims were 81.1% higher in October compared to September; this is a common pattern as seasonal summer employment ends in the fall months.

### **UI Claims Online**

The industries with the most initial claims included leisure & hospitality (581), construction (289), trade, transportation, & utilities (200), and professional & business services (171; see Table 1, page 5, and Figure 4, page 6). Industries that showed substantial over-the-year decreases in initial claims included construction (-55, or -16%) and government (-38, or -21.0%), while trade, transportation, & utilities had the largest increase over the year (19, or 10.5%).

The number of out-of-state claimants (499) was more than double the number of claimants from any one county. This is due to the large number of non-Wyoming residents laid off from jobs in industries like construction and leisure & hospitality. The counties with the most initial claims were Laramie (210), Teton (202), Natrona (189), Campbell (82), and Sweetwater (82) counties (see Figure 4, page 6, and Table 3, page 9).

#### **Continued Claims**

The total number of continued weeks claimed increased from 5,411 in October 2022 to 6,179 in October 2023 (768, or 14.2%; see Table 2, page 7). Over the month, continued claims increased 12.7% and followed their normal seasonal trends. The number of unique claimants increased from 2,146 in October 2022 to 2,331 in October 2023 (185, or 8.6%). The industries with the most continued weeks claimed included leisure & hospitality (1,099), trade, transportation, & utilities (1,067), construction (1,002), and professional & business services (685; see Figure 6, page 8). Over-the-year decreases in continued claims were seen in government (-76, or -15.6%) and construction (-52, or -4.9%). All other industries showed over-the-year increases in continued claims, led by trade, transportation, & utilities (229, or 27.3%), leisure & hospitality (125, or 12.8%), and private education & health services (105, or 19.3%).

Similarly to initial claims, there were more out-of-state continued claims (1,265) than from any individual Wyoming county (see Figure 6, page 8, and Table 4, page 9). The counties with the most continued weeks claimed were Laramie (1,069), Natrona (963), and Sweetwater (425) counties.




Figure 3: Initial Unemployment Insurance Claims by Major Industry in Wyoming, October 2022 and October 2023




Figure 4: Initial Unemployment Insurance Claims by County of Residence, October 2022 and October 2023




Figure 5: Continued Unemployment Insurance Claims by Major Industry in Wyoming, October 2022 and October 2023




Figure 6: Continued Unemployment Insurance Claims by County of Residence in Wyoming, October 2022 and October 2023

### **Box: Definitions**

**Initial Claim:** An initial claim is filed by an unemployed individual after a separation from an employer. The claim requests a determination of basic eligibility for the Unemployment Insurance benefits.

**Continued Weeks Claimed:** The number of weeks of UI benefits claimed during the reference period. An unemployed individual who has already filed an initial claim and who has experienced a week of unemployment and then filed a continued claim to claim benefits for that week of unemployment.
