Continued Claims Rise from Prior-Year Levels

ontinued Unemployment Insurance (UI) claims (see Definitions, page 9) in Wyoming increased from prioryear levels for the second consecutive month in December 2022. Before November 2022, initial claims had decreased from prior-year levels for 19 consecutive months. Initial and continued UI claims tend to increase during the winter months as seasonal workers lose their jobs and file for UI benefits.

Initial Claims

There were 2,291 initial claims in December 2022, down from 2,477 in December 2021 (-186, or -7.5%). Initial claims were also 17.6% lower than the 2,779 in December 2019 prior to the




Figure 1: Total Number of Initial Unemployment Insurance Claims for Wyoming by Year and Month, January 2012 to December 2022

pandemic (see Figure 1). From November to December, initial claims increased by 3.1%, or 68 claims.

The industries with the largest numbers of initial claims included construction (835), professional & business services (171), trade, transportation, & utilities (167), and leisure & hospitality (149). In recent months, increases in initial claims were driven by the construction sector; from

November to December, initial claims in construction increased from 610 to 835 (225 claims, or 36.9%; see Table 1, page 5, and Figure 4, page 6).

Laramie (353), Natrona (333), Fremont (176), and Sheridan (162) counties had the largest number of initial claims. In addition, there were 277 initial claims by out-of-state claimants (see Figure 4, page 6, and Table 3, page 9).


Continued Claims

The total number of continued weeks claimed increased from 10,490 in December 2021 to 11,344 in December 2022 (854, or 8.1%). The number of unique claimants increased from 3,332 to 3,976 (644, or 19.3%) over the year. However, continued claims remained 23.5% lower than the

14,833 in December 2019 prior to the pandemic (see Figure 2 and Table 2, page 7).

The industries with the most continued weeks claimed included construction (2,810), leisure & hospitality (1,059), government (1,037), and trade, transportation, & utilities (910). The greatest over-the-month increases in continued claims were found in construction (1,377, or 96.1%) and professional & business services (310, or 49.4%; see Figure 5, page 8).

There were more continued claims for out-of-state claimants (2,187) than any single county in Wyoming. The counties with the greatest numbers of continued claims were Laramie (1,634), Natrona (1,484), Sweetwater (738), and Fremont (687; see Figure 6, page 8, and Table 4, page 9).




Figure 3: Initial Unemployment Insurance Claims by Major Industry in Wyoming, December 2021 and December 2022




Figure 4: Initial Unemployment Insurance Claims by County of Residence, December 2021 and December 2022




Figure 5: Continued Unemployment Insurance Claims by Major Industry in Wyoming, December 2021 and December 2022




Figure 6: Continued Unemployment Insurance Claims by County of Residence in Wyoming, December 2021 and December 2022

Box: Definitions

Initial Claim: An initial claim is filed by an unemployed individual after a separation from an employer. The claim requests a determination of basic eligibility for the Unemployment Insurance benefits.

Continued Weeks Claimed: The number of weeks of UI benefits claimed during the reference period. An unemployed individual who has already filed an initial claim and who has experienced a week of unemployment and then filed a continued claim to claim benefits for that week of unemployment.
