Initial, Continued Claims Reach Records Highs

Wyoming had 19,199 initial Unemployment Insurance (UI) claims in April 2020, an increase of 60.2% over the month and 1,025.4% over the year. April marked the second month of unusually high UI claims due to the COVID-19 pandemic and substantial declines in the prices of oil & gas.

Initial Claims

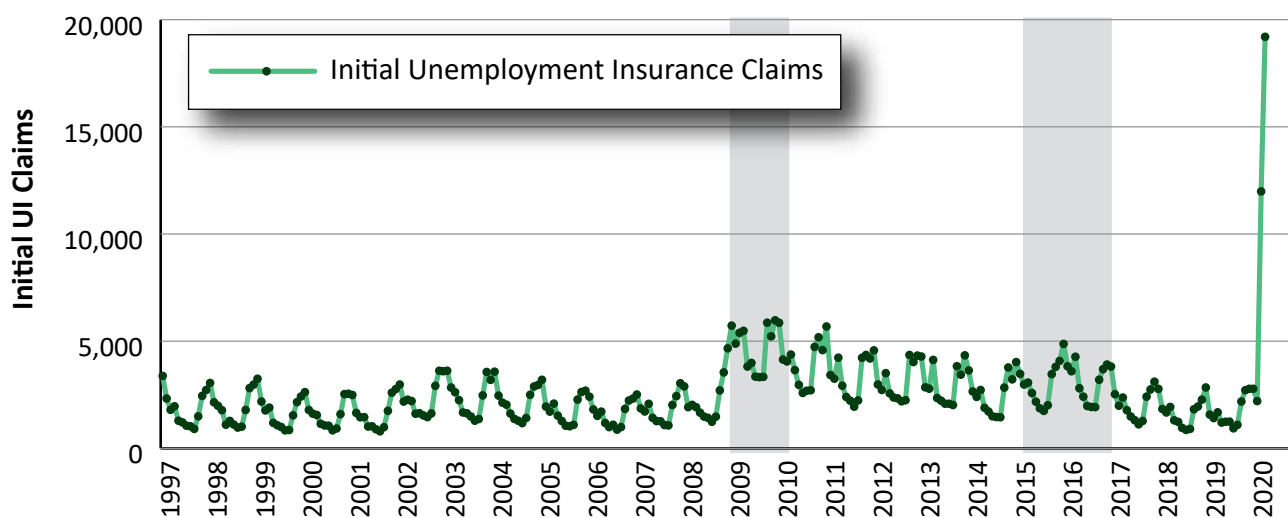
The 19,199 new initial UI claims marked substantial increases from 1,706 in April 2019 (17,493, or 1,025.4%) and 11,987 in March 2020 (7,212, or 60.2%). Prior to March 2020, the one-month high for initial claims in Wyoming dating back to 1997 (the first year for which comparable data are available) was 5,975 in December 2009. See Figure 1.

Since the start of the COVID-19 pandemic, Wyoming's leisure & hospitality industry has

been hit hardest, with 4,473 initial claims in April, up 723.8% (3,930 claims) over the year. The number of initial claims in leisure & hospitality in April was very similar to the 4,347 claims in March, an increase of 126 claims, or 2.9%. All industries experienced large over-the-year increases in initial claims, led by leisure & hospitality. The industries with the next greatest increases were trade, transportation, warehousing, & utilities (2,625, or 1,262.0%), mining (1,856, or 1,767.6%), education & health services (1,720, or 2,866.7%), and construction (1,458, or

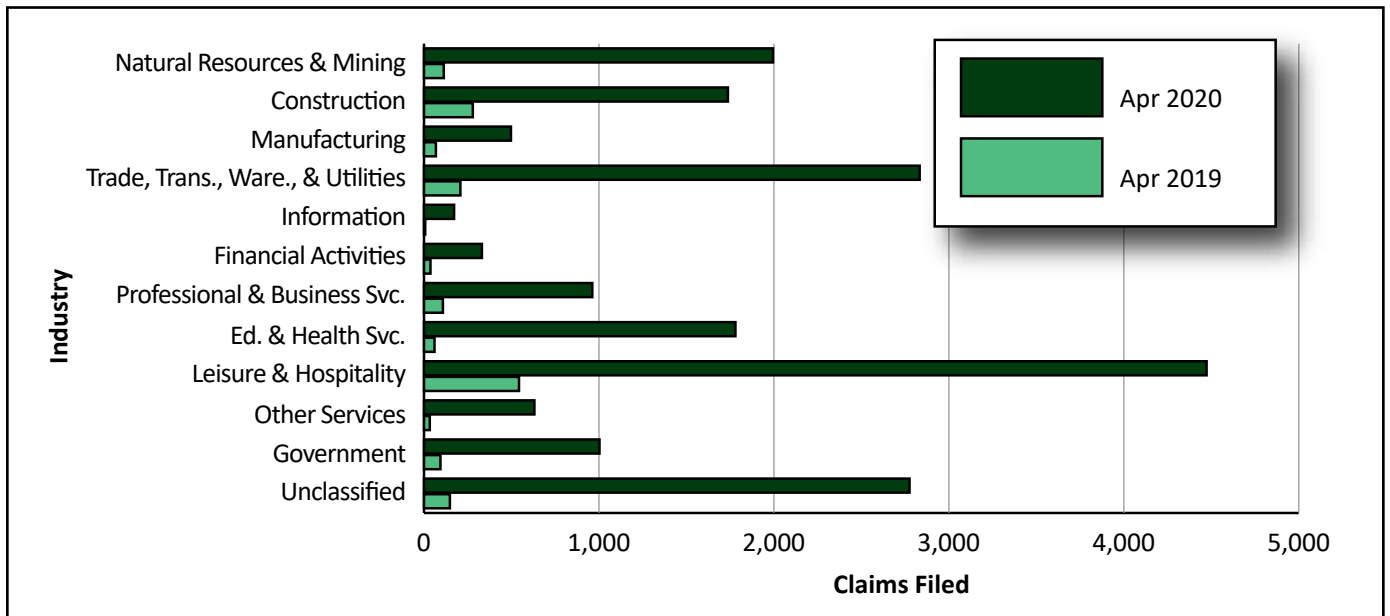


Figure 3: Initial Unemployment Insurance Claims by Major Industry in Wyoming, April 2019 to April 2020

522.6%). See Table 1 (page 5) and Figure 3 (page 6).

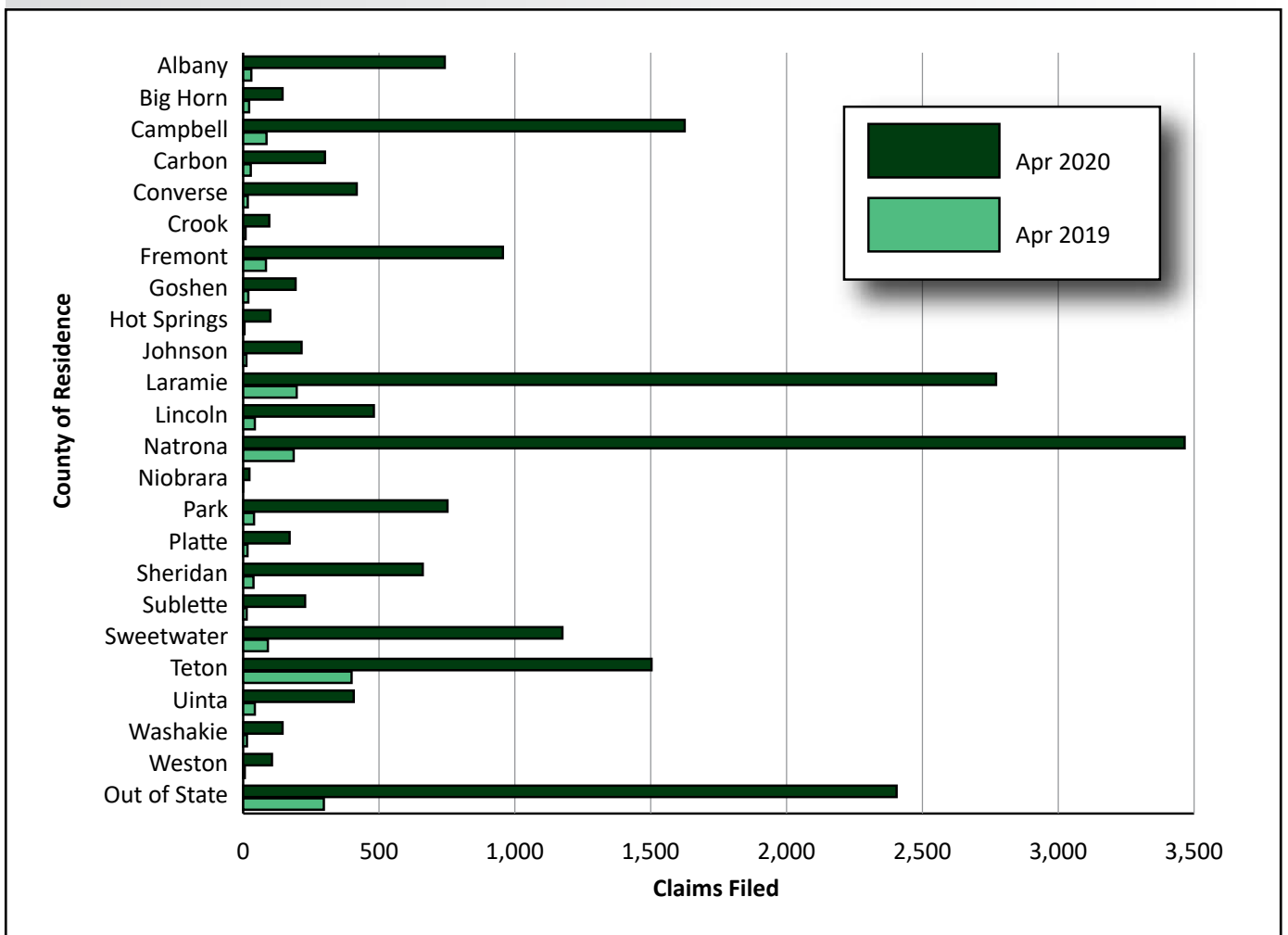


Figure 4: Initial Unemployment Insurance Claims by County of Residence, April 2019 to April 2020

At the county level, the greatest over-the-year increases were seen in Natrona (3,279, or 1,760.9%), Laramie (2,574, or 1,306.6%), Campbell (1,539, or 1,799.7%), and Teton (1,104, or 276.4%) counties. The number of out-of-state claimants increased by 2,108, or 710.8%. See Figure 4 (page 6) and Table 3 (page 9).

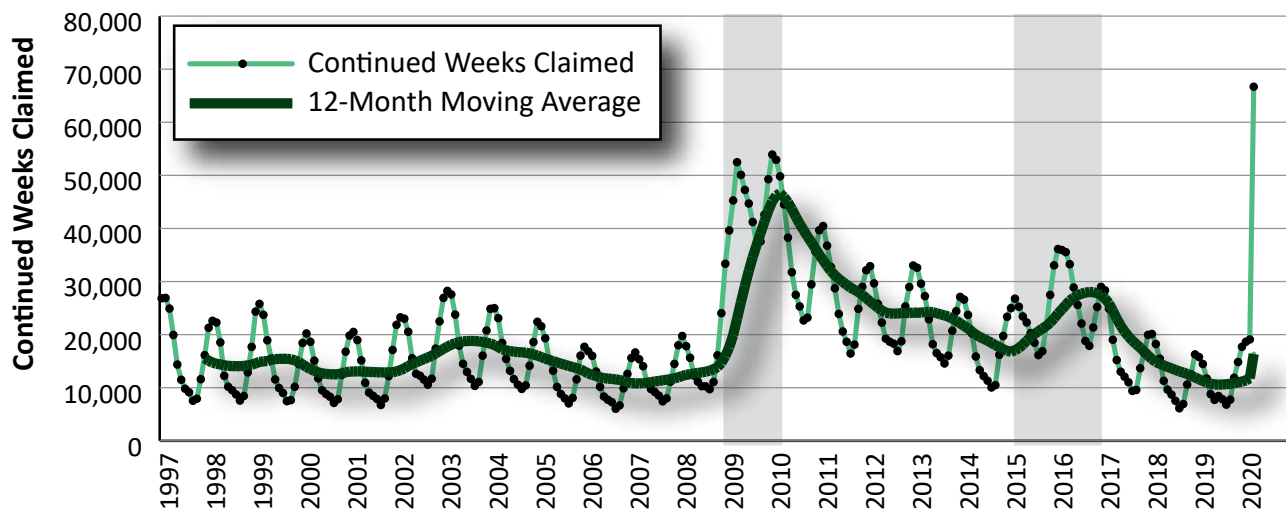
Continued Claims

The total number of continued weeks claimed in Wyoming also reached a record high level of 66,694 in April. The previous record high for one month in Wyoming was 53,920 in January 2010 during the state's economic downturn that began during the

national Great Recession. See Figure 2.

There were 17,631 unique claimants in April, up 336.6% (13,593 claimants) over the year. See Table 2 (page 7).

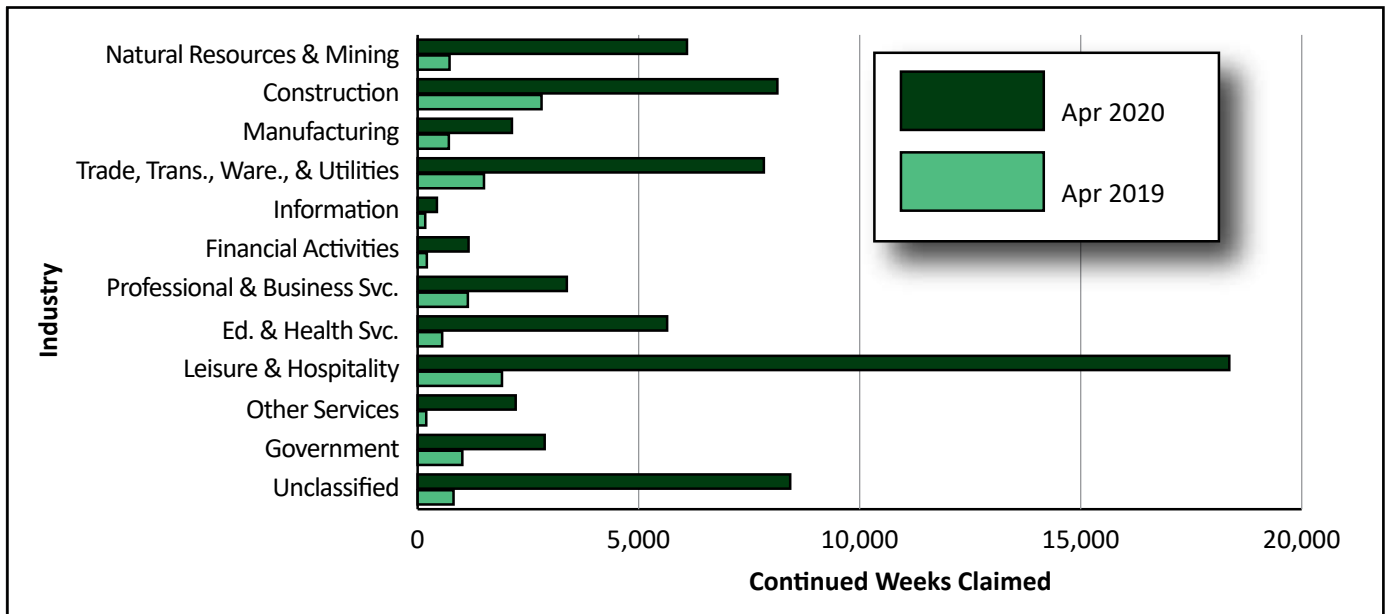


Figure 5: Continued Unemployment Insurance Claims by Major Industry in Wyoming, April 2019 to April 2020

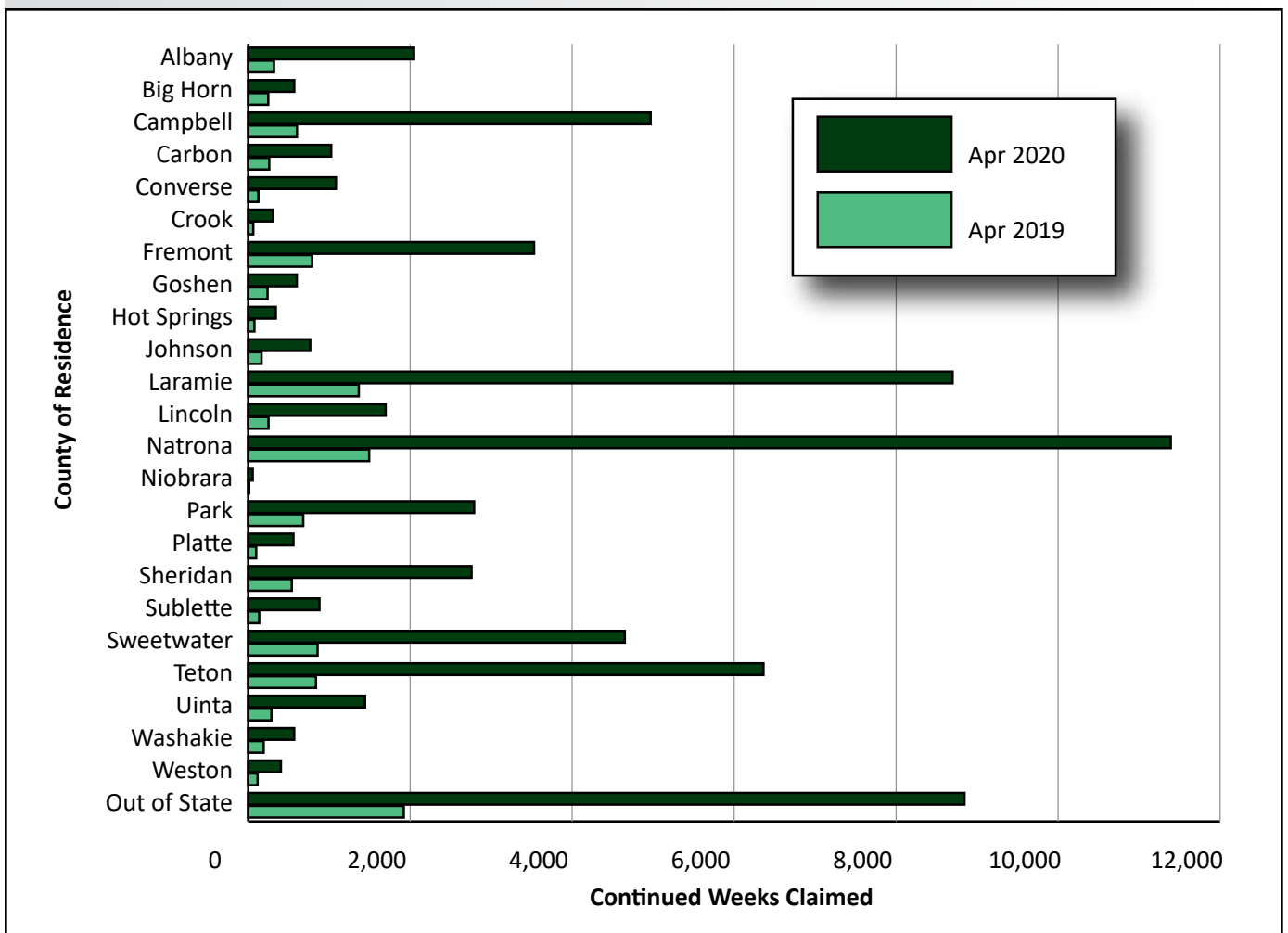


Figure 6: Continued Unemployment Insurance Claims by County of Residence in Wyoming, April 2019 to April 2020

All industries saw a triple-digit percentage increase in continued claims over the year. The greatest increases were seen in leisure & hospitality (16,453 weeks, or 862.3%), unclassified (7,616, or 937.9%), and trade, transportation, warehousing, & utilities (6,331, or 421.8%). Natrona County had the greatest increase in continued claims (9,898, or 662.6%), followed by Laramie (7,331, or 536.6%), Teton (5,525, or 660.3%), and Campbell (4,367, or 725.6%) counties. Out-of-state claimants increased by 6,922 weeks, or 360.3%. See Figures 5 and 6 (page 8) and Table 4 (page 9).

Note: The 11,987 initial claims in March presented in this report represent an increase of 1,784 over the 10,203 presented in the March 2020 Unemployment Insurance Claims Report published April 7. This difference is due mostly to wage request lag times for federal government, military, and combined wage claims. The COVID-19 pandemic caused a large increase in claims for all different UI systems, and it may take longer than usual to get wage information back for those claims and enable them to be active in the Wyoming UI system. During normal months, these types of lagging claims usually result in an increase of less than 2% once data are revised. For March 2020, however, these types of claims resulted in a 17.5% increase.
