Wyoming Unemployment Insurance Claims Report, August 2021 Initial Claims Decline for Sixth Straight Month

The number of Unemployment Insurance (UI) claims in Wyoming continued to decline from prioryear levels in August, as initial claims decreased by 75.0% and continued claims decreased by 84.7% (see Definitions, page 9). Despite these decreases, the number of initial and continued claims remained higher than pre-COVID-19 pandemic levels.

Initial Claims

20,000

August 2021 marked the sixth consecutive month of over-the-year decreases in initial UI claims in Wyoming. There were 1,282 initial claims in August 2021, down from 5,138 in August 2020 (-3,856, or -75%). This amount is getting




Figure 1: Total Number of Initial Unemployment Insurance Claims for Wyoming by Year and Month, January 2011 to August 2021

closer to pre-pandemic levels of 943 initial claims in August 2019. *See Figure 1.*

The number of initial claims declined from the prior year in all industries. In the private sector, substantial decreases were seen in natural resources & mining (-494, or -87.4%), construction (-380, or -63.9%), leisure & hospitality (-312, or -67.4%), and professional & business services (-236, or

-68.6%), among others. The industry labeled unclassified continued to be see one of the greatest decreases of initial claims (-1,584, or -89.1%). Initial claims in government decreased by 58.8% (-133 claims). *See Table* 1 (page 5) and Figure 3 (page 6).

Initial claims also decreased from prioryear levels in all counties, including Natrona (-572, or -71.3%), Campbell (-475, or -81.1%), Laramie (-441, or -68.6%), and Sweetwater (-215, or -72.6%). The number of out-of-state claimants decreased by 1,011 (-86.5%). *See Figure 4 (page 6) and Table 3 (page 9).*

Continued Claims




Figure 2: Total Number of Unemployment Insurance Continued Weeks Claimed for Wyoming by Year and Month, January 2011 to August 2021

The total number of continued weeks claimed decreased from 57,636 in August 2020 to 8,807 in August 2021 (-48,829, or -84.7%). The number of unique claimants decreased from 17,221 to 2,869 (-14,352, or -83.3%). There were 7,837 total continued weeks claimed in August 2019, so current levels are still 12.4% higher than prepandemic levels. *See Figure 2 and Table 2, page 7.*

Continued claims declined in all industries over the year, including natural resources & mining (-10,852, or -94.3%), leisure & hospitality (-5,565, or -88.2%), construction (-5,129, or 80.7%), and professional & business services (-3,395 or -84.0%), among others. Claims in the unclassified industry decreased by 84.7% (-9,061). See Table 2, page 7, and Figure 5, page 8.

Continued claims also fell in every county, with the greatest decreases seen in Natrona (-10,640, or -87.8%), Campbell (-5,213, or -86.8%), Laramie (-5,144, or -81.6%), and Sweetwater (-4,167, or -86.7%). The number of total weeks claimed by out-of-state recipients decreased by 7,823 (-85.1%). *See Table 4, page 9, and Figure 6, page 8.*




Figure 3: Initial Unemployment Insurance Claims by Major Industry in Wyoming, August 2020 and August 2021




Figure 4: Initial Unemployment Insurance Claims by County of Residence, August 2020 and August 2021




Figure 5: Continued Unemployment Insurance Claims by Major Industry in Wyoming, August 2020 and August 2021




Figure 6: Continued Unemployment Insurance Claims by County of Residence in Wyoming, August 2020 and August 2021

Box: Definitions

Initial Claim: An initial claim is filed by an unemployed individual after a separation from an employer. The claim requests a determination of basic eligibility for the Unemployment Insurance benefits.

Continued Weeks Claimed: The number of weeks of UI benefits claimed during the reference period. An unemployed individual who has already filed an initial claim and who has experienced a week of unemployment and then filed a continued claim to claim benefits for that week of unemployment.
