Initial Claims Increase 4.5% Over the Year

There were 2,186 initial Unemployment Insurance (UI) claims in October, up 4.5% from the 2,092 in October 2018. This marked the fourth consecutive month of over-the-year increases in the number of initial claims.

Initial Claims

Over-the-year increases in initial claims were seen in all goods-producing industries, while decreases were seen in all service-providing industries (see Table 1, page 4). The largest increases were seen in construction (159, or 45.0%) and mining (78, or 101.3%). The greatest decreases were seen in leisure & hospitality (-183, or -23.7%), retail trade (-22, or -23.7%), and educational & health services (-14, or -21.2%).

Initial claims increased in 13 counties, decreased in nine, and remained unchanged in Hot Springs. The largest over-the-year increases in initial claims were seen in Natrona (56, or 25.8%), Sweetwater (42, or 45.3%), and Sheridan (14, or 24.6%) counties. The greatest decreases were seen in Teton (-77, or -23.9%), Park (-14, or -13.7%), Albany

(-10, or -26.1%), and Platte (-10, or -42.3%) counties. Initial claims for out-of-state claimants increased by 5.1%, or 31 claims.

Continued Claims

Total weeks claimed increased from 7,057 in October 2018 to 7,758 in October 2019 (701, or 9.9%). The total number of unique claimants increased from 2,077 to 2,261 (184, or 8.9%) and the number of benefit exhaustions increased from 221 to 256 (35, or 15.8%).

Over-the-year increases were seen in natural resources & mining (459, or 114.2%), construction (295, or 29.8%), and manufacturing (172, or 90.5%). The largest decrease was in leisure & hospitality (-290, or -21.5%), followed by educational & health services (-145, or -24.0%).

At the county level, over-the-year increases were seen in Campbell (108, or 18.3%), Natrona (75, or 6.7%), and Goshen (72, or 48.3%) counties. Decreases were seen in Albany (-87, or -55.2%), Carbon (-48, or -43.8%), and Weston (-42, or -213.0%) counties.




Figure A: Total Number of Initial Unemployment Insurance Claims for Wyoming by Year and Month, January 2009 to October 2019

Figure 1: Initial Unemployment Insurance Claims by Major Industry, October 2019





Figure 2: Initial Unemployment Insurance Claims by County of Residence, October 2019

Figure 3: Continued Unemployment Insurance Claims by Major Industry, October 2019





Figure 4: Continued Unemployment Insurance Claims by County of Residence, October 2019
