### Wyoming Unemployment Insurance Claims Report, October 2020 Initial Claims Increase with Seasonal Job Losses




Figure 1: Total Number of Initial Unemployment Insurance Claims for Wyoming by Year and Month, January 2010 to October 2020

Initial Unemployment Insurance (UI) claims in Wyoming grew by 58.6% from September to October, marking the first over-the-month increase since April. The rise in initial claims was not unexpected; the increase in initial claims from September to October is typically the greatest of the year, because of the relatively large number of seasonal summer jobs ending. See Figure 1.

### **Initial Claims**

Wyoming had 6,073 initial claims (see Definitions, page 9) in October, up from 3,829 in September (2,244, or 58.6%). The greatest increases were seen in leisure & hospitality (718, or 157.1%), unclassified (650, or 73.0%), construction (233, or 37.6%), professional & business services

(158, or 58.3%), and federal government (149, or 496.7%). See Table 1 (page 5) and Figure 3 (page 6).

Every county saw an over-themonth increase in initial claims. The greatest increase was seen in out-of-state claimants (538, or 75.0%). Many of these claimants likely worked in seasonal or temporary jobs in leisure & hospitality or construction. The Wyoming counties with the greatest increases in initial claims

were Teton (314, or 196.3%), Natrona (313, or 45.9%), and Laramie (192, or 38.9%). *See Figure 4 (page 6) and Table 3 (page 9).* 

### **Continued Claims**




Figure 2: Total Number of Unemployment Insurance Continued Weeks Claimed for Wyoming by Year and Month, January 2010 to October 2020

The total number of continued weeks claimed decreased from 44,823 in September to 35,565 in October (-9,258, or -20.7%), while the total number of unique claimants increased from 11,394 to 11,681 (287, or 2.5%). *See Figure 2 and Table 2, page 7.* 

The decline in continued claims likely is due to a variety of factors, such as individuals returning to work, leaving the workforce, or exhausting their regular UI benefits. Federal Pandemic Emergency Unemployment Compensation (PEUC) benefits were available to individuals who exhausted their regular benefits as part of the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020. Continued claims decreased in all private sector industries, with the greatest declines seen in natural resources & mining (-2,304, or -26.3%), unclassified (-1,861, or -21.5%), and trade, transportation, warehousing, & utilities (-1,235, or -20.4%). *See Table 2, page 7, and Figure 5, page 8.* 

All 23 counties saw an over-the-month decrease in continued weeks claimed, with the greatest drops seen in Natrona (-2,245, or -23.1%), Laramie (-1,101, or -21.8%), and Campbell (-1,097, or -23.1%). Total out-of-state continued claims decreased by 1,255 (-16.6%). See Figure 6, page 8, and Table 4, page 9.




Figure 3: Initial Unemployment Insurance Claims by Major Industry in Wyoming, September and October 2020




Figure 4: Initial Unemployment Insurance Claims by County of Residence, September and October 2020




Figure 5: Continued Unemployment Insurance Claims by Major Industry in Wyoming, September and October 2020




Figure 6: Continued Unemployment Insurance Claims by County of Residence in Wyoming, September and October 2020

### **Box: Definitions**

**Initial Claim:** An initial claim is filed by an unemployed individual after a separation from an employer. The claim requests a determination of basic eligibility for the Unemployment Insurance benefits.

**Continued Weeks Claimed:** The number of weeks of UI benefits claimed during the reference period. An unemployed individual who has already filed an initial claim and who has experienced a week of unemployment and then filed a continued claim to claim benefits for that week of unemployment.
