

Wyoming Unemployment Insurance Claims Information, August 2017: Initial Claims Drop to 10-Year Low

The 1,120 initial Unemployment Insurance (UI) claims in August marked the lowest month for new initial claims in Wyoming in the last decade. Initial claims have decreased from prior year levels every month since September 2016.

However, Wyoming's labor force and monthly employment also have continued to decline. Wyoming's labor force (the number of employed persons plus the number of unemployed persons actively seeking work) declined by 7,066 (-2.3%) from July 2016 to July 2017, while the number of employed persons decreased by 2,543 (-0.9%).

There are several possible explanations for the concurrent decline in persons working and initial UI claims:

- People left the workforce entirely.
- People lost their jobs and quickly found jobs in other states.
- People voluntarily separated from their employers and found work in other states.

Initial Claims

Initial UI claims decreased by 42.0% (-811 claims) from August 2016 to August 2017.

Notable decreases occurred in natural resources & mining (-57.7% or -101 claims), construction (-53.7%, or -257), and trade, transportation, & utilities (-41.8%, or -120). All industries and counties demonstrated a decrease in initial claims, or were generally unchanged.

Continued Claims

Over the year, the number of unique claimants dropped by 50.1% (-2,689 claimants) while the number of individuals who exhausted their benefits decreased by 51.5% (-299 individuals). Total weeks claimed decreased by 50.1% (-11,062 weeks).

All counties and industries experienced a decrease in total weeks claimed over the year.






Figure: Initial Unemployment Insurance Claims for Wyoming, January 2008 to August 2017

Initial Unemployment Insurance Claims by County of Residence, August 2017




